- \*Extended Owners Policy: Gen Sched + 35%, Minimum of \$500 surcharge, ALTA Survey required
- \*Short Term Rate (insured in the last 5 years): 80%
- \*Simultaneous 1st & 2nd: 1st based off aggregate loan amount, 2nd is \$185
- \*Builder Rate: 35%, Subdivider Rate: 40%, Builder 1st Sale Out: 27%
- \*Residential Resale: 70% Gen Sched (standard owners only) - can only be combined with Combo Rate
- \*Combo Rate: If doing title and escrow Owners Policy discount 10%, Lenders 5% - can only be combined with Short Term rate,
- \*Simultaneous Issue Rate, Residential Resale Rate, and Prior Title Evidence Rate
- \*Prior policy provided: 90% for non-residential, 85% for residential
- \*Reorg Rate can not be combined with any other rate reductions
- \*Subdivision Guarantees: \$250, Lot Book Guarantee: \$75/parcel + \$5 per item shown
- \*Additional parcel charge of \$150 for each additional parcel may apply
